#### Village of The Branch – Board of Trustees Meeting September 10, 2024 Track #94

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on September 10, 2024. Mayor Delaney, Trustees Carro, Botto and Damm, Village Attorney Ring, Treasurer Mequia, and Village Clerk Cozine were present.

Mayor Delaney called the meeting to order at 7:37 pm with the pledge of allegiance.

Trustee Carro made a **motion** to approve the September 3rd, 2024, Board of Trustees work session minutes. Trustee Botto seconded the motion which was approved unanimously.

We need a speed bump as people are constantly racing down the block. Some of them are the workers at the Head Trauma on Cresthill Place. The Mayor mentioned the only issue with speed bumps are they make it difficult for the snowplows. Mayor Delaney said they make and sell removable ones and will investigate it. They aren't expensive and maybe we can get grant money for it. Mr. Heilbrun even asked if we could put a stop sign in front of his house, to slow down the speeders. Also mentioned possibly cutting down the shrubbery in front of Mr. Dagnellis house on the corner as it causes a blind spot. Mayor Delaney asked for some patience as we work on getting this done.

- Singer Lane approximate costs is \$51,000 and the breakdown is as follows: curb \$13,000, and concrete and sidewalk is \$20,000, asphalt is \$6,500 and seed \$532.00, \$7,000 excavation and \$300 sprinkler.
