Village of The Branch – Board of Trustees Meeting March 11, 2025 Track #101

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on March 11, 2025. Mayor Delaney, Trustees Carro, Botto, Damm and Ryan, Treasurer Mequia, Village Attorney Ring and Village Clerk Cozine were present.

Mayor Delaney called the meeting to order at 7:32 p.m. with the pledge of allegiance.
